Dear Notary:

The enclosed forms provide everything you need to complete the name change process. Continue to perform notarial acts in your former name until you receive the new stamp. Please return the following forms to us to complete the process:

Amended Commission Name Change Form - Please make sure all blanks are filled in. If any information is missing, your amended commission may be delayed.

Certificate of Commission - Return your current Certificate of Commission. A new certificate will be issued. If you do not have your certificate, send a short letter stating what happened to it.

Order Form - Select a package which contains a notary stamp. A new stamp reflecting your name change is required by law.

We will mail your products and certificate within 3 business days after we receive notification of your amended commission.

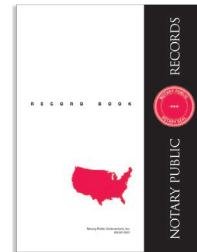

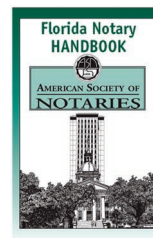
